

## Recommended Instructions for Website Disclaimers

It is permissible for Keda Industrial Group Co., Ltd. (the “Company”) to include documents containing offer-related information on its website as long as it follows the following procedures or procedures that are substantially similar to those set out below:

1. **Screen A** should pop up any time a user attempts to access a document containing any offer-related information.
2. The **Screen A** drop down box should list all countries.
